# **Read Instructions Before Using FOOTBAR® Walker**

#### **INSTRUCTIONS**

\*The following instructions apply whether the FOOTBAR® Walker is utilized by one or two caregivers.

- 1. The caregiver opens the closed walker and locks the walker side arms into the open position (\*\*see page 2). Adjust the walker to the correct height for the patient.
- 2. The caregiver places the open, locked walker arms in front of the seated patient, even or slightly past the patient's toes, to allow trunk over base of support motion.



With 2 caregivers: Caregiver A, places right hand on top bar / pull bar and right foot on foot bar. Caregiver B, places left hand on top bar and left foot on foot bar.

4. The caregiver(s), using one foot, rotates the foot bar backward and downward until making contact with the floor / ground surface using body weight to securely hold foot bar framework in place, then places opposite foot slightly behind and shoulder width apart to assume a safe, comfortable stance of strength.

5. Once the caregiver(s) has the **FOOTBAR** Walker firmly and completely secured, the caregiver instructs the patient to reach forward and grasp the top bar / pull bar using both hands by placing one on either side of the caregiver's hand (place in between if using two caregivers). Patients with limitations or without use of two arms may use alternative single handhold placement in center of pull bar only.

6. The patient pulls body forward and upward at the same time pushing upward with their legs to a standing position.

7. Once the patient is in the standing position, the caregiver instructs the patient to remove one hand at a time from the top bar / pull bar and grasp the left and right side handgrips at the top of the walker's framework.

8. After patient is fully upright and stable, caregiver SLOWLY allows foot bar to move back to the original starting, upright position.

### WARNING

NOTE: Caregiver UNDER NO CIRCUMSTANCE should remove their hand grasp from top bar / pull bar until foot bar is secured and in upright position.

9. The caregiver releases their hand grasp from the top bar pull bar and steps out of the way and to the side of patient and walker to allow ambulation.

- 10. When patient wishes to be seated, first have patient back up until back of patient's legs are touching chair, bed or seat surface. Caregiver repeats STEPS 3 through 5 of instructions. The patient, while grasping the top bar / pull bar with both hands, slowly lowers body into seated position.
- 11. Once patient is safely seated, caregiver(s) slowly releases the foot bar to upright position. Then caregiver releases their grasp of the top bar / pull bar and finally, moves the FOOTBAR Walker away from patient.

### History of the **FOOTBAR®**

Originally designed for a friend who could not stand on his own. His wife could no longer lift him and was feeling the strain on shoulders and back pain. Trying to avoid injury to herself and her husband became a challenge. The patient was an 88 year old WWII veteran recovering from his third hip replacement. He had been diagnosed with Lewy Body Dementia. The wife, age 86, was the sole caregiver and wanted to keep him home as long as possible. The inability to stand placed physical pressure on her and threatened his ability to stay home or move to a nursing home.

After many attempts, a revelation changed the entire design making the FOOTBAR what it is today an aid for both the patient and caregiver. Soon, others began asking for the FOOTBAR Walker. With no plans to make a commercialized product, demand persisted and in 2017 & 2019 the FOOTBAR acquired two patents.

The walker was designed for those with a disability or limited mobility. Patients love it because they are not pulled and tugged on. Caregivers love it because it allows the patient to do the lifting rather than the caregiver. Utilizing this walker will not prevent a patient from tripping or falling. Check with physician before use. The FOOTBAR Walker must be utilized by a physically & mentally capable caregiver that understands how to properly use and follow instructions.

DO NOT attempt to use top bar / pull bar / foot bar functions and features without a caregiver present. Without a caregiver present to operate, the walker offers patient no assistance to stand or be seated and should not be used for this purpose.

DO NOT use on stairs or escalators.

FALL RISK: Weak or fall risk patients should consult physician before use.
